Confirmation of REACH Compliance

Dear Customer

The European REACH regulation on the Registration, Evaluation, Authorization and Restriction of Chemicals [Regulation (EC) No 1907/2006] came into force on June 1, 2007. The chemicals currently produced in the EU or imported into the EU market were pre-registered between June 1 and December 1, 2008. Companies that pre-registered their substances can benefit from extended registration deadlines. The deadline depends on the tonnage band and the hazardous properties of the substance.

The deadline for REACH registration for substances expired on June 1, 2018.

With this letter, ELIX Polymers would like to confirm that all ELIX products of the product lines *ELIX ABS*, *ELIX PC/ABS*, *ELIX Ultra*, *ELIX 1XX* series, *ELIX 2XX* series and *CADON ABS* are in full compliance with the REACH legislation.

Polymers and polymeric preparations produced by ELIX Polymers:

Polymers and polymeric preparation, this means all ELIX Polymers products, are exempt from the obligation to register. Therefore, ELIX polymeric products do not have to be registered and have no registration number that could be reported to you.

Nonetheless ELIX Polymers hereby confirms that all monomers forming the polymer in an amount of ≥ 2 % weight by weight, as well as all additives have been registered by us or our suppliers.

ELIX Polymers has received confirmation of REACH compliance from all our suppliers. In addition, we adjusted our purchasing workflow in order to ensure that only raw materials are used for the production of our polymer products, which have been registered by its manufacturer or importer.

Candidate list of Substances of Very High Concern (SVHC) for Authorization:

On June 25, 2025 ECHA published the latest version of the Candidate list of Substances of Very High Concern for authorization (SVHC) now containing 250 chemicals. This list is regularly updated when more substances are identified as SVHC.

ELIX Polymers hereby confirms that none of the substances mentioned in this list has been intentionally added to or is known to be present in the products of our *ELIX ABS, ELIX PC/ABS, ELIX Ultra, ELIX 1XX series, ELIX 2XX series and CADON ABS* product lines.

ELIX Polymers also confirms that our *ELIX ABS, ELIX PC/ABS, ELIX Ultra, ELIX 1XX series, ELIX 2XX series and CADON ABS* product lines comply with requirements of CLP Regulation 1272/2008/CE on "Classification, packaging and labeling of dangerous substances" and with the restrictions set by the REACH Regulation 1907/2006/CE, Annex XVII and following amendments.
